#### What is Yooldo Games (ESPORTS) and how does it work?

Yooldo is a Web3 gaming platform that combines multiple games, events, community features, and digital asset management within a single application, allowing players to play, earn, and manage on-chain assets within one ecosystem. The platform includes a community "Jury" feature that enables users to review certain in-game or community-related matters. A companion site, Yooldo Verse, provides a blockchain explorer and a bridge that allows players to hold, view, and transfer their digital game assets securely within the ecosystem.

ESPORTS is Yooldo's native utility and governance token. It is used for staking to participate in governance, purchasing in-game content and digital assets, and receiving rewards distributed through the platform's incentive pool.

#### Who is behind the project?

Yooldo is developed by Catze Labs, a Web3 gaming and technology company founded by DoHeon Shin.

#### Tokenomics of ESPORTS

ESPORTS has a total supply of 900 million. The initial allocation was distributed as follows:

### General Risks

Like all other digital assets, there are some general risks to investing in ESPORTS. These include short history risk, volatility risk, liquidity risk, demand risk, forking risk, code defects, cryptography risk, regulatory risk, concentration risk, electronic trading risk and cyber security risk. ### Risks specific to ESPORTS

#### *Competition*

The Yooldo platform faces competition from other Web3 gaming ecosystems such as Immutable (IMX), Ronin (RON), Gala (GALA), and many others. ESPORTS derives its value from the broader adoption of the Yooldo platform in the market. If the Yooldo platform fails to achieve sufficient adoption compared to the other options in the market, this could negatively impact the value of ESPORTS.

### Due Diligence

Prior to listing on the Kraken platform, Kraken performed due diligence on ESPORTS and determined that Kraken was permitted to make ESPORTS available for trading to UK users, in compliance with UK law. This process generally consists of reviewing publicly available information on the following:

- The creation, governance, usage and design of ESPORTS, including the source code, security and roadmap for growth in the developer community and, if available, the background of the developer(s) who created ESPORTS;
- The supply, demand, maturity, utility and liquidity of ESPORTS;
- Material technical risks associated with ESPORTS, including any code defects, security breaches and other threats concerning ESPORTS and its supporting blockchain (such as the susceptibility to hacking and impact of forking), or the practices and protocols that apply to them; and
- Legal and regulatory risks associated with ESPORTS, including (i) any pending, potential, or prior civil, regulatory, criminal, or enforcement action relating to the issuance, distribution, or use of ESPORTS, and (ii) consideration of statements made by any regulators or securities regulatory

authorities in the UK, other regulators of the International Organization of Securities Commissions, or the regulator with the most significant connection to ESPORTS regarding whether ESPORTS, or generally regarding whether the type of crypto asset, is a security and/or derivative.
